## Minutes of

Tengizchevroil LLP Future Growth Project -Wellhead Pressure Management Project

**Consultation Meeting** 

Venue:	School building, Turgyzba village, Zhylyoi District, Atyrau Oblast
Date & Time:	October 9, 2018

16:30 - 18:00

**R. Artygaliev, TCO General Manager, Policy, Government and Public Affairs,** informed participants that TCO continues holding annual consultation meetings with Atyrau Oblast Community. The objective of the meeting was stated, which was to give an overview on work progress within TCO FGP - WPMP, and listen to the audience opinion regarding TCO and Project. He emphasised that the consultation meeting was not a public hearing. It was stated, that presentation about the Project would be introduced followed by Q&A Session, and if attendees would like to address their requests in written form, they could use special forms provided to each attendee. R. Artygaliev noted that in case of any further queries the attendees could address TCO by the contact information provided in handouts distributed to all the meeting participants.

It was emphasized by R. Artygaliev, that TCO contacted to all attendees who addressed written requests on previous meeting and provided answers to their questions.

Further, as per the agenda, Nurtas Kenganov, FGP-WPMP Regulatory Affairs Manager, delivered a presentation on TCO and FGP-WPMP activities.

Further R. Artygaliev informed the community on the status of sports centre construction project in Turgyzba village. It was noted that in 2017 the Atyrau Oblast Akimat excluded this project from the list of projects implemented as part of Egilik social program. However, recently the sports centre construction project was re-incorporated to the program. Currently the documentation required for sports centre construction is being prepared.

Then the Q&A Session started.

**Pensioner:** There is a difference in wages of Chevron and Contractor employees.

**R. Artygaliev (TCO):** The issue related to Contractors' wages is beyond TCO competence since they are separate legal entities.

Pensioner: Are there any residents of Zhylyoi District among employees?

**R. Artygaliev (TCO):** Yes. However, please remember that employment peak period on the project falls within 2019-2020. Personnel reduction is anticipated after this period. We are working

in this direction in cooperation with the relevant state authorities. It is expected that there will be about 600 permanent jobs in TCO Base Business after completion of FGP-WPMP construction.

**Pensioner:** I kindly ask you to assist with employment of my grandson. His occupation is electrician, driller. He has work experience.

**K. Joldasbayev (TCO):** It is necessary to register on ENBEK.KZ web-portal, monitor the job openings and apply for suitable jobs to get employed on FGP-WPMP project. Project Contractors post open vacancies on this portal. The web-portal owner is the RoK Ministry of Labour and Social Protection of Population. Please invite your grandson right now and I will explain him how to register on the web-portal.

**Question:** You have built a kindergarten and will construct a sports centre soon. Will the assistance provided to local communities be stopped after that or TCO will continue allocation of funds for social projects?

**R. Artygaliev (TCO):** There are two social investment programs in TCO: Egilik Social Infrastructure Development Program and TCO Community Investments Program. Earlier TCO had a small and medium business financing program but this program was closed since TCO is not a financial institution. As part of community investments program TCO is implementing the Zharkyra Social Entrepreneurship Development Program in cooperation with Eurasia Foundation of Central Asia. You can propose your projects for implementation as part of this program. We will recommend Eurasia Foundation of Central Asia to deliver an overview presentation on this program for Zhylyoi District community.

**Question:** You are kindly requested to include the targeted assistance for residents into the social investment program.

**R. Artygaliev (TCO):** Consideration of such program for each district is within the Akimat's competence. If the Akimat develops a program package, it can be further reviewed, we determine the scope that can be executed as part of TCO social program and the scope that will be executed by Akimat for budget funds. We will communicate the issues raised by population to Atyrau Oblast Akimat.

**A. Toremuratov:** I kindly ask TCO to assist with construction of a race course near the village.

**R. Artygaliev (TCO):** You need to address this request to Atyrau Oblast Akimat to include the race course construction to Egilik Social Infrastructure Development Program. We will also communicate your request to Atyrau Oblast Akimat.

**N. Balgimbayev:** I kindly ask TCO to assist with construction of a bridge over the crossroad. It is the place where trains pass creating traffic jams.

**R. Artygaliev (TCO):** You are also requested to address this project to Atyrau Oblast Akimat for review and further incorporation to Egilik program.

Question: What is the status of the cultural centre construction?

**R.** Artygaliev (TCO): The cultural centre construction project was not submitted to TCO.

A. Toremuratov: Who prepares the design and estimate documentation for projects?

## R. Artygaliev (TCO): Akimat

**Question:** It is necessary to add an additional public bus stop in the village, lighting is required on the village outskirts.

**R. Artygaliev (TCO):** These projects can be included to Egilik program. You need to address this request to Atyrau Oblast Akimat. And we, on our part, will communicate your request to Atyrau Oblast Akimat.

A. Toremuratov: Will the Kazakhstan's share in the agreement change?

**R. Artygaliev (TCO):** No, it will not change. Currently the partners are Chevron (50%), ExxonMobil (25%), KazMunaiGas (20%), and LukArco (5%).

**L. Sargozhiyeva:** We kindly ask you to construct a cultural centre in the village. Children travel to Kulsary to attend the clubs. Schools have a lot of problems. Recently major repair works were performed in the school; however, the walls and doors are already in a bad condition.

**R. Artygaliev (TCO):** The Akim of the village should send a request for construction of a cultural centre to Atyrau Oblast Akimat. As I noted, TCO will also communicate all received requests to Akimat.

**Question:** My daughter is a process technician by occupation, recently she participated in the job fair but no success. Where shall the young specialist contact to? Are there any programs in TCO?

**R. Artygaliev (TCO):** It is necessary to register on ENBEK.kz web-portal for employment on FGP-WPMP project. Please invite your daughter, our specialists will explain the process.

Question: Is there any young specialist employment project?

**R. Artygaliev (TCO):** Such a project does not exist. As part of community investments program TCO can support the young specialists in entrepreneurial business.

**E. Tulepov:** I am a physical education teacher. We have seen the sports centres constructed under your program. Rooms for wrestling are small, there is not enough space for this sport. We kindly ask you to expand the design of wrestling room in the sports centre to be constructed in Turgyzba village.

**R. Artygaliev (TCO):** As it was noted, the design and estimate documentation is provided by the Atyrau Oblast Akimat. TCO constructs the facilities as per design provided by the Akimat. We will communicate this to Akimat.

**A. Toremuratov:** We kindly ask you to assist with construction of embankment on the river to ensure the rational use of water in Zhem river.

**N. Muratov (TCO):** Currently Kursai river cleaning works are ongoing. It is expected to complete the project next year. There is a possibility to include an additional scope of work to this project through Atyrau Oblast Akimat.

**R. Artygaliev (TCO):** The possibility of including the embankment construction to this project will be reviewed when preparing the documentation of sports centre construction project.

## Conclusion

R. Artygaliev thanked the residents for participation and noted that consultation meetings with the community will be arranged every year until the completion of the project.
